ORDER:

In the reference 7th read above, the Director General, State Disaster Response & Fire Services, Andhra Pradesh has stated that since the AP Fire Services Act, 1999 came into force, Fire Services Department has been issuing fire NOCs to different occupancies mentioned in Section-13 of A.P. Fire Services Act, 1999 duly prescribing the fire safety measures as stipulated in the National Building Code of India, as amended from time to time.

2. The Director General, State Disaster Response & Fire Services, Andhra Pradesh has further stated that from the year 2020 to 2022 the then Director General State Disaster Response & Fire Services, Andhra Pradesh, issued Fire NOCs by suggesting decentralized fire safety measures and 2HP, 5HP, 10HP plunger pumps as an alternative to National Building Code of India fire fighting systems and issued Notifications in the Andhra Pradesh Gazette from 1st to 6th read above.

3. The Director General, State Disaster Response & Fire Services, Andhra Pradesh, has further stated that the Gazette Notifications issued from 1st to 6th read above that prescribes the fire safety measures other than NBC norms which are causing confusion amongst the stakeholders, whether to install decentralized plunger pumps like 2HP, 5HP, 10HP (or) the pumps and other fire safety systems prescribed by NBC such as 1620 LPM, 2280 LPM & 2850 LPM for fire fighting purpose.

4. The Director General, State Disaster Response & Fire Services, Andhra Pradesh, has further stated that the Hon'ble Supreme Court in Avinash Mehrota Vs Union of India in W.P.No.483 of 2004 has dealt with an important public interest litigation relating to a fire swept wherein the Hon'ble Supreme Court after examining all the relevant factors with reference to the factual and legal aspects was pleased to issue certain direction so as to ensure the building safety as below:

"Before granting recognition or affiliation, the concerned State Government and Union Territories are directed to ensure that the buildings are safe and secure from every angle and they are constructed according to the safety norms incorporated in the National Building Code of India"

5. The Director General, State Disaster Response & Fire Services, Andhra Pradesh has therefore requested the Government to annul all the above 6 Gazette notifications as they are contrary to NBC norms and AP Fire Services Act, 1999.

6. In the reference 8th read above, Government had constituted a Committee to study the issues of Fire Services Department whether the Gazette Notifications issued from 1st to 6th read above are in inconformity with the AP Fire Services Act, 1999 and NBC Code and to study whether the equipment mentioned in Gazette Notifications, conform the standards of NBC Code for fire safety.

7. In the reference 9th read above, the Committee after detailed study of Gazettes, Act, Rules and numerous meetings with various stake holders across the state and country, submitted following recommendations on each Gazette Notification issued by the then Director General, State Disaster Response and Fire Services, Andhra Pradesh.

Fire Service Act' 1999 and A.P. Fire & Emergency Operations and Levy of Fee Rules' 2006 shall be strictly followed i.e. to follow NBC Guidelines. However, to avoid any practical difficulties, revised fire safety measures may be issued by State Government as per recommendation from the fire dept like in Uttar Pradesh, Mumbai & Delhi.

8. After careful examination, Government have accepted the recommendations of the Committee and a copy of the Report was communicated to the Director General, State Disaster Response and Fire Services, Andhra Pradesh, with a request to furnish necessary proposals as per the recommendations of the Committee vide reference 10th read above.

9. In the reference 11th read above, the Director General, State Disaster Response and Fire Services, Andhra Pradesh, has stated that the Committee opined that the Gazette Notifications issued in 2022 are mainly focused on plunger pumps without any justification and these pumps are no where used in India for fire fighting purpose.

10. The Director General, State Disaster Response & Fire Services, Andhra Pradesh, has therefore requested the Government to annul all the six (6) Gazette Notifications and enable the Fire Services Department to follow the fire safety measures as per the guidelines of NBC as stipulated under Section-13(2) AP Fire Services Act, 1999.

11. Government after careful examination of the matter, hereby annul the Gazette Notifications issued from references 1st to 6th read above and directed to follow following recommendations made by the Committee:

- (i) With regard to Fire Safety Measures, the provisions as laid in A.P. Fire Services Act, 1999 & A.P. Fire & Emergency Operations and Levy of Fee Rules' 2006 shall be strictly followed i.e. to follow National Building Code of India Guidelines. However, if any practical difficulties would occur while implementation, the State Government is empowered to issue revised fire safety measures based on the recommendations from the Fire Department.
- (ii) With regard to Setbacks & Open Spaces, the local authorities i.e., Municipal Corporations, Panchayats, IALA, SEZ and APIIC shall ensure that the setbacks shall be as per local building rules as amended from time to time.

12. The Director General, State Disaster Response and Fire Services, Andhra Pradesh, Vijayawada, shall take necessary further action in the matter, accordingly.

The Government further directed to follow the recommendation made by the committee with regard the Fire Safety Measures, the provisions as laid in A.P.Fire Services Act, 1999& A.P.Fire, & Emergency Operations and Levy of Fee Rules 2006 shall be strictly followed i.e., to follow National Building Code of India Guidelines. However, if any practical difficulties would occur while implementation, the State Government is empowered to issue revised FIRE safety measures based on the recommendations from the Fire Department and regarding to Setbacks & Open Spaces, the local authorities i.e, Municipal Corporations, Panchayats, IALA.SEZ and APIIC shall ensure that the setbacks shall be as per local building rules as amended from time to time.

3). Therefore all the officers in the state are instructed to follow the orders issued vide G.O reference cited without fail.

4). Any deviations are noticed in this regard will be viewed seriously and action will be initiated accordingly.
