**ORDER:**

Under section 18 of the Disaster Management Act, 2005, the State Disaster Management Authority (SDMA), is authorized to lay down the State Disaster Management Policy, to approve the State Plan in accordance with the guidelines, laid down by the National Authority and approve the Disaster Management Plans, prepared by the Departments of the State Government etc., Accordingly, the Revenue (DM-III) Department, in the reference first read above have issued orders constituting four Sub-Committees for Floods, Urban Floods, Cyclones and “Restructuring of Fire and Emergency Services Department” and also requested to nominate Members for the committee including experts in the field and submit report to the Government.

2. Government have constituted a Sub-Committee in the reference 2<sup>nd</sup> read above for “Restructuring the Fire and Emergency Services Department” under the Chairmanship of Hon’ble Minister for Home, and Principal Secretary, Home Department as the Member/Convener along with other experts in the field.

3. The Sub-Committee has accepted the report on “Restructuring of A.P. Fire and Emergency Services”. The Report contains several recommendations including the change of the name of the present “Andhra Pradesh Fire & Emergency Services Department” to that of “Andhra Pradesh State Disaster Response and Fire Services”.

4. Government after careful consideration and keeping in view of the recommendation made by the Sub-Committee” on Restructuring of Fire and Emergency Services Department” hereby change the nomenclature of A.P. Fire and Emergency Services Department to that of **Andhra Pradesh State Disaster Response and Fire Services Department”**.
