In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Andhra Pradesh hereby makes the following amendment to the Special Rules for the Andhra Pradesh Fire Subordinate Service, issued in G.O.Ms.No.568, Home (Prisons,A) Department, dated the 24th November, 1992 and published at pages 1632-1637 of Part-I of the Andhra Pradesh Gazette dated the 10th December, 1992:-

AMENDMENT

In Annexure-I of the said rules, under Column-3, against category "(1) Assistant Divisional Fire Officers", after the words "the National Fire Service College of the Government of India", the following words shall be inserted namely:-

"OR

Must have undergone the refreshers course of Station Fire Officers for three months at Andhra Pradesh Fire Service State Training School, Hyderabad".
