Sub: General Association Department - Services Welfare - Exemption from Transfers for the Office Bearers of A.P. Non-Gazetted Officers' Association till they complete present three (3) years term or nine (9) years stay in their respective working stations i.e at State / District / Taluk Level Head quarters - Orders - Issued.

Government in the reference 3rd cited, have reiterated the instructions regarding exemption of transfers of Office Bearers of all the Recognized Service Associations and instructed that Office Bearers of Recognized Service Associations shall not be transferred from Districts / Divisional / Taluk Head quarters before completion of three terms or two terms as the case may be viz., six years of their tenure in such office(s) i.e three terms for those having two years as the term of office or two terms for those having three years as term of office. In the reference 4th cited, Government have further clarified that, the previous service rendered by the Office Bearers of Recognized Associations need not be taken into account while calculating the six (6) years term as Office bearers of Recognized Service Associations during six (6) years period of Office Bearers.

2. In the reference 5th cited, the President / General Secretary, A.P. Non-Gazetted Officers' Association have represented that their Office Bearers are going to be transferred in the middle of their tenure as they have completed six(6) years of continuance service at their working places resulting dislocation of Office Bearers of their Association and that it is very difficult to fill the post from the same Department and they have requested the Government to issue necessary orders not to transfer the Office Bearers of A.P. Non-Gazetted Officers' Association, at Taluk/District/State Level till they complete present three(3) years term or nine(9) years of service; as the elected Office Bearers have to attend the welfare of the employees working in that particular station.

3. Government after careful examination of the request of the President / General Secretary, A.P. N.G.O.'s Association have considered the issue and hereby ordered all the Heads of the Departments and all the District Collectors to retain the Office Bearers of A.P. Non-Gazetted Officers' Association, for one more term of three(3) years for those who are completing six(6) years of term at present in their respective working places i.e State/District/Taluk Level Head quarters. However, the Competent Authorities can effect such transfers on administrative grounds even before present three (3) years term or the expiry of the nine (9) years period after recording the reasons.

4. The above relaxation orders accorded in para (3) are applicable only to the Office Bearers of A.P. Non-Gazetted Officers' Association and not for any other recognized Service Associations.
