**ORDER:**

In the letter 2<sup>nd</sup> read above, the Director General, State Disaster Response and Fire Services, Andhra Pradesh, Vijayawada, has submitted proposals with the recommendations made thereon by the Departmental Technical Committee constituted for the purpose regarding authorization of **third party** for conducting inspections related to issuance of No Objection Certificate by the Fire Services Department for buildings where there is a fire risk. Utilization of **third party** services will expedite approvals, as the Fire Services Department has limited manpower.

2. Government, after careful examination of the matter, and in partial modification of the existing rules issued vide G.O.1<sup>st</sup> read above, hereby order that the Director General, State Disaster Response and Fire Services, may authorize a **third party**, after taking due approval from the Government, to conduct inspections as proposed in the Andhra Pradesh Fire and Emergency Operations and Levy of Fee Rules, 2006 and submit report to the Director General, State Disaster Response and Fire Services, Andhra Pradesh, Vijayawada, for issue of "Provisional NOC".
