ORDER:

Government of India, Ministry of Health & Family Welfare has communicated the approval of Government of India for setting up of AIIMS in Andhra Pradesh under Pradhana Mantri Swasthya Suraksha Yojana (PMSSY). The Central Government has approved the site suggested by the Government of Andhra Pradesh at Mangalagiri.

2. In the letter 1st & 3rd read above, the Director (PMSSY) has informed that the Project Executing Agency, M/s HSCC (India) Limited, has initiated the process of submission of the drawings to the local municipal authorities including Fire Department. It has been informed that an amount of Rs.9,07,695/- (@ Rs.10/sqm of proposed area) as Fire Precaution Fee along with a Bank Guarantee @ 15% of the estimated cost of Fire-fighting systems/equipment being installed (amounting to Rs. 1,37,20,305/-) is to be deposited to the Fire Authorities. Apart from this, a fee amounting to Rs.10000/- is to be deposited to the Local Municipal Authority as building permit fee. These fees only pertain to the Construction of the Residential Complex and the OPD Block. The process for other buildings shall be taken up after the finalisation of their drawings and details. The above is a Project of national importance being funded by the Ministry of Health, Government of India and it will majority benefit the people of State of Andhra Pradesh.

3. The Director, (PMSSY), Government of India, Min of Health and Family Welfare has requested for waiver off the building permission charges and to issue general directions for waiving off all charges and fee relating to approvals for different components of AIIMS and exemptions for all statutory / regulatory clearance for the construction of AIIMS, Mangalagiri.

4. The Government after careful examination of the matter, here by waive off building permission charges and waive off fire precaution fee and Bank Guarantee requisite by the fire authorities / Municipal authorities for establishment of AIIMS at Mangalagiri, Guntur District, A.P.

5. Government also hereby issue the general directions to all the concerned departments to exempt all the statutory / regulatory clearances for quick completion and construction of AIIMS.

- i. One time conversion charges (Non-Agricultural Land Assessment - NALA)
- ii. Fire Precaution Fee
- iii. Bank Guarantee @15% of estimated cost of Fire-fighting System/equipment being installed

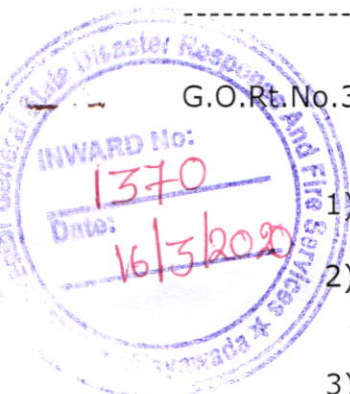
3. The above exemptions are provided as a onetime measure and shall not be treated as precedent
